

Entry Requirements

Titling your Entry

Title your entry followed by the competition name.
(For example. *TRIPS should be Renegotiated: Revising TRIPS for Public Health: An Ideas Contest from MSF*)

Length

Written text: 500 – 1000 words (excluding footnotes and references)
Audio visual: 5 minutes (max)

Entry Form

For your submission to be considered you must complete, sign and scan in a copy of the entry form which can be downloaded from the MSF Access Campaign website (<http://www.msfacecess.org/>).

How to submit written entries

Submit written entries to: DohaPlusTen@paris.msf.org, together with your completed, signed and scanned entry form.

How to submit your audio visual entries

Youtube

Please submit video or audio entries through YouTube. This will make processing your entry easier and faster.

1. Sign in to, or create, a Youtube Account for yourself.
2. Upload your entry (video or audio) to this Account.
3. In the Broadcast and Sharing Options select the Private option

Access to Knowledge Policy and Release of Rights

Médecins Sans Frontières (MSF) is organizing the 'Revising TRIPS for Public Health: An Ideas Contest' with the goal of contributing to the global exchange and access to knowledge. We therefore encourage you to provide open access to your work by dedicating it to the public domain or licensing under a Creative Commons Attribution License that will allow anyone to use your work, so long as the original authors and source are cited. If you choose to participate in the contest, MSF will ask you to sign the entry form representing and warranting that your work has not been previously published or is being considered for publication elsewhere, that the work is an original creation of authorship, and that the work does not infringe upon rights of others.

The entry form also authorizes MSF to publish, distribute, reproduce, display, publicly perform, incorporate in one or more collections or archival systems,

modify and create derivative works and adaptations, including translations, your work in any media and format now in existence or which may be developed in the future, including the Internet. The above rights include the right to make such modifications as are technically necessary to exercise the rights in other media and formats.

We also ask you to further assign to MSF any rights which you may have in any audio or video recording of your presentation and any panel discussion that you may be involved in at the invitation of MSF, and you authorize MSF to reproduce, exhibit, broadcast and distribute that recording, in any media and format now in existence or which may be developed in the future, including the Internet. The above rights include the right to make such modifications as are technically necessary to exercise the rights in other media and formats.

We ask you to waive any right to compensation that you may have now or in the future from MSF for the use of the work or any right obtained by the agreement. MSF will not receive any payment from you for the publication/use of the work.

You retain the exclusive right to be credited as the author. You also retain the right to reproduce, distribute, publicly perform, and publicly display the work in any medium for any purposes; the right to prepare and distribute derivative works from the work; and the right to authorize others to make any use of the work.
